

# REACH COMPLIANCE

### Safety Data Sheet and REACH Compliance

#### Safety Data Sheets

A Safety Data Sheet (SDS) is a document that contains information on the potential health effects of exposure to chemicals, or other potentially dangerous substances, and on safe working procedures when handling chemical products.

By SDS definition paper is an “article”.

“Article” means a manufactured item: (i) which is formed to a specific shape or design during manufacture; (ii) which has end use function(s) dependent in whole or in part upon its shape or design during end use; and (iii) which does not release, or otherwise result in exposure to, a hazardous chemical under normal conditions of use.

Papers manufactured by the mill conform to the definition of “article” and therefore do not need a Safety Data Sheet.

#### REACH

REACH is a European regulation which entered into force in June 2007. The regulation covers registration, evaluation, authorisation and restriction processes for chemical substances to ensure the consistency of regulations across the EU. These REACH processes are designed to provide additional information on chemicals, to ensure their safe use and to ensure competitiveness. Following the UK’s withdrawal from the EU and the subsequent transition period, the EU REACH Regulation has been brought into UK law on 1 January 2021, under the European Union (Withdrawal) Act 2018. REACH, and related legislation, have been replicated in the UK and the key principles of the EU REACH Regulation have been retained.

None of the substances contained in the current (June 2020) ECHA-SVHC list are used in the manufacture of paper products at the mill is therefore satisfied that the papers supplied to our customers comply with the current 59 (10) REACH regulations and do not require registration procedures.
